Description of Work/Operation (Including Plant and Equipment)

This risk assessment aims to identify potential hazards associated with visitors and employees whilst using the facilities at Hogshaw farm and Wildlife park and control measures in place to reduce the risks/hazards to an acceptable level.

People exposed to these risks are generally workers who handle or restrain animals or enter the enclosures.

The risk to vulnerable groups such as pregnant women, anyone with health conditions is increased, including members of the public. Schools – Whilst the site is closed to the general public on Mondays and Tuesdays, we will be booking in school groups on these days.

We will book a maximum of 2 school groups per day on these days with rotation schedules and separate indoor space usage

Our buildings are well ventilated to minimise dust and good quality bedding and feed are used. Animal interaction	Visitors to the attraction and employees involved in the task	4	1	4	Zoonosis, disease passed from animals to humans, can be avoided by practicing good hygiene. Visiting guided groups will be given a talk on arrival to make children aware of this. Non-guided groups will be issued with a site map, which contains this advice on the reverse side. Visitors should not eat or drink in the animal area and should not touch their faces (eyes, ears, nose, mouth) whilst on the farm. 					Remember even if a person has not touched an animal there is still a risk in touching fencing where animals are kept. Washing facilities are provided around the Farm. Clear 'wash your hands' signs are displayed. No one should kiss or put their face on an animal and children will be supervised during hands-on activities by farm and visiting staff. Additionally, best practice is in place to ensure our animals are healthy, cases of animal ill-health are dealt with		
Vehicle movement with the attraction	Visitors to the attraction and employees involved in the task	5	1	5	by farm staff quickly and efficiently. We will not move vehicles within the farm during opening hours unless absolutely necessary. Should such an instance occur the vehicle will have a walking escort and move at walking speed. When disembarking from the coach be aware there will be other visitors arriving in their own vehicles. Advice to ensure the coach parks away from other vehicles in our designated coaches area, is given as part of the pre-visit pack and signs are in place to designate coach parking. Children disembarking the coach should be gathered together as one group under the supervision of the group leader. A member of farm staff will guide the group from the coach into the farm via the safest route to avoid vehicle movements. Groups arriving in separate vehicles must produce their own risk assessment to demonstrate how children will be met from the car park and supervised in a safe manner. Environment	Visitors to the attraction and employees involved in the task	4	1	4	Weil's disease is carried in the urine of rodents, and rodent control is carried out to reduce this. Weil's disease can be found in still water, information regarding Weil's disease is passed onto all schools who could come into contact with water such as pond and ditch water for example during pond dipping activities. Whilst we cut back stinging nettles in high use areas, we also acknowledge their value to wildlife, thus stinging nettles and thorny plants such as brambles are present on our site. 					not to touch. Visiting adults can help to prevent scratches and stings by helping children to identify and avoid touching such plants. We advise all visiting groups to encourage their children to wear long trousers to avoid exposure. Stings and bites from insects can be kept to a minimum by encouraging children to wear long trousers and t-shirts that cover the chest and shoulders. Avoiding sugary drinks and sweets in picnic foods during the summer months will also help not to attract wasps. This advice forms part of the information given to the children by the group leader as part of their pre-visit information. We will provide an advisory leaflet to all visiting groups as part of the previsit information. We have wasp traps on site and remove nests when present. The group leader should be aware of anyone in their group with an allergy to insect stings and ensure they have their prescribed emergency medicine, this information should be shared with farm staff via the booking form and on the day. Exposure to the weather can be a risk to health, visiting adults should ensure children are appropriately dressed for their visit and we will provide an advisory leaflet as part of the previsit information to help with this. Farm and group leaders should be vigilant to signs of a child or children becoming too hot or cold. Alternate indoor activities will be available to cater for instances when it is not appropriate to be outside as a result of extreme weather or lack of appropriate clothing worn by visiting
